To consumers within the service area of the Association subject to the rules and regulations of the Association and of Regulatory Authorities.

AVAILABLE:

To irrigators pumping irrigation water.

TYPE OF SERVICE:

Single-phase or three-phase, 60 hertz, at available secondary voltage.

MONTHLY RATE:

Facilities Charge:

\$8.85 per Installed HP/Year which is to be billed in July.

Demand Charge:

\$11.45 per kW/Month

Energy Charge:

\$0.07920 per kWh

ANNUAL MINIMUM BILL:

The annual minimum bill shall be the higher of the following, subject to the provisions of the line extension policies:

- A. \$15.00 per nameplate horsepower and not less than 5 horsepower for single-phase service and 10 horsepower for three-phase service; or
- B. As specified in contract for service.

DETERMINATION OF INSTALLED HORSEPOWER:

The installed horsepower for billing purposes shall be the manufacturer's motor nameplate rating or, at its option, the Association may determine the horsepower by test under conditions of maximum operating load.

DETERMINATION OF BILLING DEMAND:

The billing demand at each station shall be the maximum kilowatts of demand established by the consumer for any period of fifteen (15) consecutive minutes during the month for which the bill is rendered, as indicated or recorded by a demand meter and adjusted for power factor as provided below.

POWER FACTOR ADJUSTMENT:

Demand charges will be adjusted to correct for average power factors lower than ninety-five percent (95%) if and when Association deems necessary. Such adjustments shall be made by increasing the measured demand one percent (1%) for each one percent (1%) by which the average power factor is less than ninety-five percent (95%) leading or lagging.

TERMS OF PAYMENT:

Payment for all bills for electric service must be postmarked ten (10) days following the date of bill mailing. Bills not paid by the next following bill date may be assessed a one and one-half percent (1.5%) late payment charge. This charge will be on the delinquent balance brought forward on the subsequent month's bill.

Payments received shall satisfy the oldest portion of the billing first.
