Recently, I attended the Legislative Rally in Washington DC where we had the opportunity to hear from various speakers on issues at the national level and meet with our national legislators. It is always an educational opportunity to visit our nation's capitol and see the history, but to be able to speak directly with those individuals we elected to represent us at this level was a very special occasion. Senator Barrasso gave us a copy of a report from a committee he chaired for the Senate, along with Representative Lummis, for the House of Representatives. This report, (Principled Stewardship of the American West) begins with the statement of belief that "The American West is an immense area of land that varies from rugged mountains and highland prairies to rolling hills and painted deserts. The wildlife, weather, and resources in the West are diverse, unique and spectacular."

The report goes on to talk about our abundant natural resources of energy, food, timber, and minerals and how these resources improve the lives of people everywhere, not just in our own states. The report states that "The Senate and Congressional Western Caucuses believe that the people who live on the land in the West are the best stewards of the land.



Our main goal is to empower the residents, workers and local leaders in the West and throughout the nation to make the decisions that best serve their families and their communities." The report lists specific principles and expands on them. I believe this report is logical and direct, and provides thoughts to support and preserve economies while remaining responsible stewards of our environment. I encourage you to stop by our office and pick up a copy of the report and see what our elected officials have put together.

I believe this report takes us back to the intent of the Founding Fathers of our nation, where if I recall my government history correctly, during the development of the Constitution, the Founding Fathers debated whether to have a strong central government or let the states have the authority to rule themselves, with the feds taking only a limited role. I am not a constitutional expert and that high school class was a long time ago, so I don't remember the details. However, I do believe there was significant discussion on this issue well over 200 years ago, and today, some politicians have forgotten this history. As a result, we are seeing an attempt to expand federal authority outside the intent of our Founding Fathers. "One size" does not "fit all" for very many things, and legislation is no exception. Our nation's Founding Fathers recognized this and provided the means for us to govern ourselves as states.

If you haven't been by the office within in the last few months, you might want to stop by and see some of the remodeling we have completed. We removed all the old tile and are in the process of replacing that with new tile and carpet. We also painted the lobby, hallways, and the bathrooms. The warehouse has new OSHA approved shelving that replaced 50 year old shelving. We are trying to make improvements a little at a time. Now with the nice weather, it is hard to get those linemen to work indoors, so remodeling is being put on "hold" for a while.

I hope everyone is still keeping alert to the EPA and all of its regulations. 111(d) and other regulations did not go away. Several lawsuits have been filed against this regulation so expect the issue to be in the courts for a long time. There is an election coming up, and it would behoove us all to keep on top of "what is happening". Remember, these rules can affect your electric rates in the future.

Surge protector leases are still only \$4.95 per month.





What's this? It's your "pole number" (Well, somebody's pole number)! Why is it important to you? Because it is the number the linemen look for on our system map to find you. If you look on your meter pole, you will find a series of 2" aluminum numbers and letters similar to the ones in the picture above. If you give these numbers to the operator at the office, or to the call center after hours, you will help the linemen find you quicker, which means shorter outage times.

West Circuit, Wheatland Substation


North Circuit, Goodrich Substation


